Attention I-Pay Users

Effective September 1, 2014, all passwords for I-Pay must be 8 characters in length. If your current I-Pay password is not eight characters long, you will have to change it to conform to this new requirement.

Changing your password is very simple.

Sign in to I-Pay bill pay and choose "options." Next select "change pin" and follow the instruction to change your password.

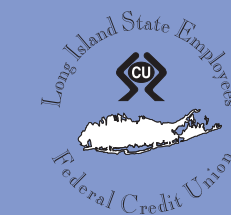
