- 1. It's Quick:**
IRS claims it can speed up your refund by 3 weeks.
- 2. It's Safe:**
No lost/stolen checks
- 3. It's Easy:**
There is no need for you to make a special trip to the credit union. Just complete the refund section of your tax form with Long Island State Employees FCU, Routing # (221492002), and your member account number.

3 Tips for Good Credit

- 1.** You can correct your credit report when it is in error. Your credit report is the summary of your financial reliability – your history of paying debts and other bills. Typically, there is no single credit report. Most likely each of the three major credit bureaus – Equifax, Experian and TransUnion has a report on you. Federal law requires these credit bureaus to investigate any complaint you bring to them in writing, usually within 30 days. - 2.** You can take steps to improve your credit score. Your credit score is a number used by lenders to evaluate your credit-worthiness. Many lenders use a system called the FICO Score. As a rule, a good score will mean better chances of getting credit at an attractive rate, so taking steps to improve your score can be well worth the effort. Here are some steps to take: **Pay Bills on time • Keep credit card balances low • Keep debt to less than 30% of your available credit**
- 3.** Monitoring Your Credit is FREE. You can get a free copy of your credit report every year from each of the three national credit reporting agencies. That means you can monitor your credit year-round, ordering a report from each of the three once every four months. There is only one online source authorized to give you your report for free: www.annualcreditreport.com



This Month's Questions from Our Members

Q: How can I save money on my auto insurance?

Check your policy at each renewal to verify that all of the appropriate discounts are being applied. Rates will vary depending on usage and drivers. There are a variety of credits given to young drivers including those for good students. Reduced rates for low mileage are available as well. Liberty Mutual policyholders are eligible for a group discount for LISEFCU members. Be sure to complete the defensive driving course every three years in order to maximize savings.

Q: How do I know which vehicles will cost more to insure?



Vehicles are rated using "symbols" which is a numerical value assigned to a particular model. Many variables may go into determining a vehicles symbol. Some of those are...the resale value, cost of repair, theft occurrence and safety. Call your agent prior to purchase for the cost to insure a certain vehicle on your policy. Once again...check all the discounts!

Q: I've heard that it costs more to insure a red car. Is that true?

No. Although there are many factors that go into determining the auto insurance premium... the vehicle color is not one of them.
